Inspection: Items offered for sale are used over an extend period of time, have exceeded their useful life, are worn out, decayed, used up, obsolete, deteriorated, or lost its value, may be nonconforming, and contain defects not immediately detectable. Bidders may and are strongly encouraged inspect the property prior to bidding. Bidders must adhere to the inspection dates and times indicated in the item description. The responsibility to determine the condition of the surplus property rests with the bidder. Prospective bidders are encouraged to inspect the surplus property prior to bidding, and to place bids based solely on their personal inspection and evaluation. Prospective bidders will not be allowed to test, operate or disassemble any item featured in the sale.

Consideration of Bid: Seller reserves the right to reject any and all bids and to withdraw from sale any of the items listed.

Notice of Award: Successful bidders will receive a Notice of Award by email from Seller.

Payment Terms: Payment in full is due not later than five (5) business days from the time and date of the Notice of Award. No item may be removed by the purchaser prior to making full payment.

Payment shall be in the exact amount only in the form of: Cash (U.S. currency only); Cashier's Check; Certified Check; Money Order. Checks and money orders shall be made payable to: MSD of Wayne Township.

Payments are accepted only at MSD of Wayne Township, at 1220 South High School Road, Indianapolis, IN 46241.

If paying by MAIL, send purchaser's payment to the same address, along with a photo copy of purchaser's Driver's License or BMV ID. Also, if purchaser intends to send a designated

representative or common carrier to pick up the property, include a signed letter of authorization identifying the representative or carrier and personal identification such as a Driver's License or BMV ID.

Property Removal: All property is located in the Seller's buildings in Indianapolis, IN. The Buyer, designated representative, or common carrier must provide a copy of the email award notification received from Seller and personal identification such as a Driver's License or BMV ID to the Area 31 office.

All items must be removed within twenty (20) business days from the date of issuance of the Notice of Award. Surplus property will be released only upon receipt of full payment as specified.

Successful bidders are responsible for loading, removal, and transportation of any and all surplus property awarded to them from the address where it is being stored by Seller.

Seller personnel are under no obligation and are not required to assist in loading items if requested by the Buyer. Under no circumstances will anyone other than trained and authorized personnel be allowed to operate material handling equipment on Seller's property.

Seller will not be responsible for any personal injuries or damages to any vehicle or other equipment during the loading of surplus property.

The Buyer will make all arrangements and perform all work necessary for packing and transportation of the surplus property. Under no circumstances will Seller assume responsibility for packing or shipping. Surplus property may be removed between the hours of 7:00 AM and 4:00 PM, Monday through Friday, excluding legal holidays and shall be scheduled a minimum of two business days in advance.

Default: Default shall include (1) failure to observe these terms and conditions; (2) failure to make good and timely payment; or (3) failure to remove all items within the specified time. Default may result in termination of the contract and suspension from participation in all future sales until the default has been cured. If the Buyer fails in the performance of their obligations, Seller may exercise such rights and may pursue such remedies as are provided by law.
