The Qualified Provider to whom the work is awarded shall conform to the wages determined for this project. All Proposals must contain the content and, in the format, described within the RFP.

The Board reserves the right to terminate this project prior to bid being received, to reject any and all proposals and to be the sole judge of the value and merit of the proposals offered.

#### **SECTION I. - OVERVIEW**

**MSD Wayne Township** requests proposals for the implementation of energy conservation measures at MSD Wayne Township Schools on a performance contracting basis. The Board will make their own energy conservation decisions and financing selections. The Owner's objectives in issuing this Request for Proposal (RFP) is to provide a competitive means in which to select a single Qualified Provider to perform the implementation of a Guaranteed Energy Savings Contract (GESC). The contract shall follow I.C. 36-1-12.5 and **RFP** Qualified **Providers** auidelines. must Email Barry at barry.gardner@wayne.k12.in.us the RFP Response. The cost of preparing a response to this RFP, including site visits and engineering analysis will not be reimbursed by the Owner.

Each proposal will be reviewed to determine if it is complete prior to actual evaluation. The Owner reserves the right to eliminate from further consideration any proposal deemed to be substantially or materially unresponsive to the requests for information contained herein.

## **SECTION II. - QUALIFICATIONS**

• Responses shall include a concise review stating the respondent's understanding of the project contained on no more than three pages.

# Company Qualifications Company

#### Profile:

- Provide general information on the responding firm including company name, address, telephone number, and evidence of Qualified Provider status under I.C. 36-1-12.5, contact person for this project.
- Where is the company's local office located?
- How many years has the company/parent or subsidiary operated in Indiana performing Guaranteed Energy Savings Projects as the Lead?
- How many years has your company been involved in providing guaranteed savings contracts?
- Do you have a Solar Service and Facility Management department and if so, how many service professionals do you currently employ? List the contracts you currently service/manage and names of references. Companies that self-perform Solar Services & Facility Management in Indiana will receive a higher score.
- Please document and verify current customers that your firm has installed Solar Canopy Solutions as part of your ESC Contract? (what was the contract value?). Those Firms demonstrating Completed positive projects will receive a higher score.
- An Up to-date letter of Bond capacity and ability to complete the project showing aggregate project bonding amount.
- When was the responding firm's first energy project installed in State of Indiana? Who was the customer? How big was the project and details?

## **Project Team:**

- List the personnel employed by the Qualified Provider involved in this project. Include a resume on each person listing name, title, education, experience, work history and responsibilities on this project. Identify specifically the type of work performed by each person and for how long.
- Legal Grievances: The Qualified Provider shall describe in detail any federal investigations, failures to complete, or legal litigation related to the company or any of its construction projects, over the past 10 years.

- Past performance is a critical component in the selection process of this project. - Annual guaranteed and actual energy savings <u>Certifications</u>:
- I.C. 36-1-12.5 requires that Qualified Providers submit with their proposal certification from the Indiana Department of Public Works that they and their subcontractors (for all subcontracts in excess of \$150,000) are certified to perform the work included in their proposal. This statute also requires that each Qualified Provider be a Certified Professional Services company that employs a minimum of one full-time employee registered in the State of Indiana as a Professional Engineer.
- Include a copy of the certification(s) from the Indiana Department of Public Works that proves the Qualified Provider is a Certified Professional Services Company.
- Include the names and PE numbers for all fulltime employees who are professional engineers registered in the State of Indiana.

- Each Qualified provider shall provide any completed drawings associated with each ECM as part of their submittal. Any advanced work effort that can assist on advancing the project timeline shall be considered favorably in the selection. Qualified Providers providing detailed engineering Solar Canopy designs and one- line drawings will receive higher scores.

# Performance Guarantee / Energy Calculations Energy

## Savings & Project Costs:

• At minimum an aggregate of energy projected savings/costs and assumptions shall be included in the proposal.

#### Performance & Payment Bond:

- The Qualified Provider must submit to the Owner a 100% Performance & Payment Bond following contract execution to insure the performance of the construction portion of the project. A subsequent Performance Bond shall be executed to insure the performance of the guaranteed energy savings.
- All Sub-Contractors in excess of \$50,000 shall be required to submit performance bonds.
- All Bonds will be renewed on an annual basis until contract completion.

# Performance Guarantee Agreement:

• Each Qualified Provider must complete the energy savings, operational savings, and total savings amounts along with providing guarantee language that reflects the savings being guaranteed within the Qualified Provider's proposal and the savings verification methodology being proposed. Energy savings and operational savings shall be tracked separately and a shortfall in energy savings cannot be offset with excess operational savings. The Qualified Provider shall refund the Owner for any energy shortfall experienced during the guaranteed savings contract.

#### **SECTION III. - EVALUATION CRITERIA**

#### Minimum Criteria:

- Certificate of Indiana Guaranteed Energy Savings Contract (GESC) Provider
- Performance and Payment Bond
- Insurance Certificate
- Completed Proposal

The Owner intends to award a contract to the Qualified Provider offering the Best Value proposal. The Owner will likely reject any proposal that does NOT meet the minimum criteria described in this RFP. For proposals meeting or exceeding the minimum criteria, the Owner will score the Qualitative Proposals based on the criteria shown below. The calculation that shall be used to determine the Best Value proposal is the price for the scope of work offered by each Qualified Provider divided by the Qualitative Score assign to each proposal by the Committee to arrive at the lowest net price, or Best Value proposal.

Should a Responder to this RFP be unable to meet any of criteria set forth above the responder may explain the basis of such inability and may assign a cost savings to such inability for consideration by owner.

Proposals shall be evaluated on criteria weighted as follows:

Qualified Provider's Experience and Qualifications 20% Proposed Project Development and Construction 15% Proposed Project Management and Performance 15% Financial Considerations: Costs, Savings & Guarantee 25% Lead Times on Essential Equipment 25%
